Hole In One Inc. (HIO) hereby agrees to reimburse the applicant named on this Contract, up to the specified maximum prize value if a Hole-In-One (as defined by the USGA or CPGA Rules of Golf) occurs on the date(s) as specified. Such payment shall be subject to the following Warranties and Variable Tournament Conditions. Only the first Hole-In-One will be awarded the prize on each hole. HIO endeavors to ship the prize signs on time for the tournament, but is not liable for delays caused by the shipping company.

WARRANTIES & CONDITIONS

(Read Carefully)

A BEFORE TOURNAMENT

1. CONFIRMATION OF TERMS - HIO will forward a contract for review and signature prior to the event. Any revisions to the contract must be submitted to HIO for approval prior to the event.
2. PAYMENT - Payment and a signed contract must be received 24 hours prior to the event. Payment by check, money order or credit card accepted. Coverage is not provided without receipt of payment and a signed contract.

B DURING TOURNAMENT

1. WITNESSES - One adult (21 years of age), non-participating observer, appointed by the Tournament Committee shall be stationed at the top prize hole during the event. Prize values exceeding \$25,000 require two observers; one at the green, the other at the tee-off area. Prize values exceeding \$100,000 require a law enforcement official as the second observer. Witnesses are optional on the bonus prize holes, unless otherwise specified.
2. YARDAGE - The selected hole(s) will measure from teeing ground to flagstick no less than the yardage printed on the Golf Club's Score Card and must meet the specified minimum yardage requirements. The hole yardage must play to the Score Card yardage and cannot be reduced to meet the minimum requirements. Grand prize minimum yardage for men is 165 yards and for ladies 150 yards. Men and ladies play at the same minimum yardage for the bonus prizes. Only one hole may be used as the top prize hole. Temporary greens and tee-off areas are excluded.
3. SHOTS - No practice shots or Mulligans are permitted. Only the authorized number of shots is permitted during the stipulated round(s) of the named tournament. A ball hit out of bounds, and the shot replayed, does not qualify. Each player takes one shot and one shot only at the prizes, unless otherwise specified.
4. ELIGIBILITY - The Hole-In-One must be shot by an officially registered competitor in a group of three or more. Twosomes are not eligible.

C AFTER TOURNAMENT

1. CLAIM NOTIFICATION - Immediate telephone, fax or email notice by the applicant to the claim department of HIO must be reported no later than the first business day after tournament.
2. PROOF OF CLAIM - The following documentation must be provided to HIO as proof of Hole-In-One claim:
 - a) Attested statements by the appointed observer(s), the successful competitor, and all playing partners.
Proof of Claim Form provided by HIO.
 - b) A signed and completed score card of the competitor.
 - c) Certified copy of Tournament Roster Sheet by Golf Course Professional or Tournament Director supervising the tournament.
 - d) Proof of Claim must be submitted no later than 60 days after the tournament date, otherwise the claim is deemed void.

The claim process begins upon receipt of all required documents. Claims are generally processed in 15 business days.

3. DISPUTED CLAIMS - All USA disputes shall be resolved by the laws and courts of Lee County, State of Florida. Canadian disputes shall be resolved by the laws and courts of The Province of Ontario. All parties are liable for their own attorney fees. HIO may, at their option and expense, require a polygraph test of winners and witnesses.
4. PRIZES - HIO is responsible for the prizes only on the specified day(s) of the tournament. HIO reserves the right to substitute the bonus Hole-In-One prizes with prizes of equal or greater value.
The Golf Vacation prize consists of a \$1,999 Vacation Voucher to be applied to any golf package offered by Merit Golf Vacations. Packages include accommodations, greens fees, golf cart, tee times, and local car rental with unlimited mileage. Airfare not included. Merit offers over 50 destinations, more than 120 resorts and 600 golf courses worldwide.
The 3-day Bahamas Carnival Cruise prize departs Miami, Florida, with a category 4 interior cabin. Port charges and government taxes are extra. Blackout dates may apply. Coach airfare from select major cities is included. Additional airfare may apply from other cities. Prizes must be accepted as awarded, with no cash substitution, and must be claimed within one year.

VARIABLE TOURNAMENT CONDITIONS

Any variation to the specified tournament data, postponement or cancellation due to weather conditions requires notification to Hole In One, Inc., prior to the start of the tournament. Telephone messages are recorded 24 hours a day, 7 days a week. Fax and e-mail transmissions are also acceptable.

NUMBER OF PLAYERS

The fee on the Contract is based upon the number of players submitted by the applicant. If the actual number varies by more than 5%, HIO must be notified and a fee adjustment requested prior to the event.

WEATHER CONDITIONS

If a tournament is cancelled due to inclement weather, the event may be rescheduled at no additional cost. If weather conditions terminate play during the event, a credit for the number of players who did not shoot at the prizes will be applied to the rescheduled event. If the event is not rescheduled within 90 days, a \$65 fee for administrative/signs/kits/freight will be applied and a refund issued for the balance.
